

House Rules for Livingston Amateur Radio Klub Gambling

A. House Rules for The Livingston Amateur Radio Klub Inc, with proceeds being raised for the benefit of the Livingston Amateur Radio Klub Inc's emergency fund. For the purpose of fund raising for up keep of the Klubs equipment.

B. License number **_R97389_** will be printed on each ticket and ticket stub for the purpose of identifying the current game and winner.

C. Each ticket will have a cost of **_\$ 20.00_** per ticket. With a limited number of tickets printed of **_150_** There will be no limit to the number of tickets each person can purchase up to the number of tickets available for sale. There will not be any additional tickets printed.

D. The wining ticket will be drawn on the following date **_SEPT 11 2008** time **9:00-9:30** and at the following location. **_300 SOUTH HIGHLANDER WAY , HOWELL MI 48843**

The first ticket drawn will be awarded the first prize and the second ticket drawn will be awarded the second prize and the third ticket drawn being awarded the third prize. Each ticket will be entered in to a container from which one person will draw the first ticket from after the tickets have been mixed for a reasonable amount of time. After the winner has been identified then the second and third prize will be awarded accordingly. If winner is not present on the date of the drawing an appointment can be set to claim their prize or it can be claimed at the next available board or membership meeting.

E. In the event that the raffle can not take place due to inclement weather or extenuating circumstances the raffle drawing will then be held at the next membership meeting with an announcement being printed in the Klub's newsletter.

F. The redemption claim period for the raffle (charity game tickets) is within 60 days of the finial date that the drawing was held. Winner need not be present to win prize (s).

G. The redemption claim period for the raffle of numeral game tickets such as 50/50 tickets is at the time of the drawing and must be present to win.

H. All sales of tickets are final at time of sale with no refunds being made at any time for any reason. The Klub reserves the right to purchase any or all unsold tickets.

I. The House rules for the Livingston Amateur Radio Klub Inc are effective on the following date **MAY 18 TH 2008 THUR SEPT 11 2008** for this drawing only and all rules are subject to change for each future raffle license and will be posted at time of license issuance.

These house rules are available when licenses have been applied for and will be posted on our website at <http://www.w8lrk.org> they will be available at each Klub function for review as well as a copy available with each person providing tickets for sale. Anyone requiring a copy of the house rules can send a self addressed stamped envelope to The Livingston Amateur Radio Klub Inc, Po Box 283, Howell MI 48844 and a copy will be mailed as requested.

Each person purchasing a charity game ticket understands that the prize amount awarded to them may be taxable under Federal and State taxation departments and that Federal and State requirements may include the issuance of a 1099 G if necessary, and possible back up withholding taxes. The winner(s) also understands that they will be responsible for providing the proper identification including picture ID such as current drivers license or state ID along with social security card. Failure to provide proper ID will result in the winners forfeiture of the prize if not claimed within 60 days at such time a second drawing of the remaining tickets will be awarded at the next meeting date after the expiration date of 60 days has passed.

The Livingston Amateur Radio Klub Inc's house rules shall be posted in a conspicuous place and or made available upon request. The house rules shall not be in conflict with the act, these rules, or directives of the bureau.
